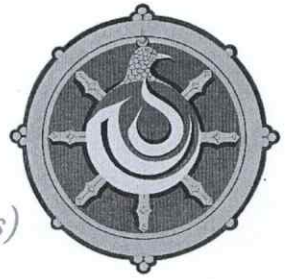

Terms & Conditions

1. The quotation will be rejected if the seat(s) is not confirmed during the submission of the quotation;
2. The quotation should reach the Administration and Finance Division, Election Commission of Bhutan, Thimphu on or before at 27 March 2024 at 12:30PM;
3. The bidder is requested to mention the name of the airlines and submit confirmed itineraries;
4. The validation of fares and availability of seats should be as per the details mentioned above;
5. The bidders must enclose copies of valid licences, tax clearance certificates, and power of attorney (if applicable);
6. No cancellation charges shall be applicable unless the tickets have been purchased by the client (ECB);
7. Any other conditions or policies such as “non-refundable”, non-transferable” and charges for change of date, name, etc.” must be specified during the time of the submission of the quotation with a specific timeline mentioned;
8. Lowest evaluated bidder who receives the award shall issue the tickets;
